COMMUNITY LED VISION

In June 2019, Harlem Township initiated updating its Comprehensive Plan, first adopted in 2008. The Harlem Township Steering Committee, appointed for this task, convened between December 2019 and May 2021.

Over eighteen months, the Committee held initial meetings at the Township Hall, focusing on communicating Township conditions and gathering public input.

A survey, yielding 374 responses, highlighted community preferences, notably the desire to maintain the Township's rural character. Balancing this with limited commercial development, the Committee aimed to preserve large lot development and prevent annexation.

The plan outlines five key goals derived from the survey: maintaining the rural character, protecting cultural and natural resources, expanding open space, developing within community service capacities, and safeguarding agricultural uses.

Detailed chapters analyze Township demographics, land use, transportation, and development patterns, aligning findings with community preferences and feasibility.

The 2020 Harlem Township Comprehensive Plan was Adopted November 2021




INTEL ANNOUCEMENT JANUARY 2022




On January 21, 2022, Intel Corporation announced a \$20 billion investment in microchip manufacturing plants in neighboring Jersey Township, impacting the Columbus Region and situated just a few miles from Harlem Township. Recognizing the significant development risks, Township officials acted. In March 2022, the Township Trustees appointed a **Strategic Planning Committee (SPC)** and engaged Crossroads Community Planning, LLC, to assist in implementing the **2020 Comprehensive Plan** amid impending development. Crossroads conducted a thorough planning process, including a SWOT (Strengths, Weaknesses, Opportunities, and Threats) analysis and research on infrastructure and development pressures, resulting in specific recommendations outlined in a **Quick Strategy Guide (QSG)**

The **Quick Strategy Guide** supplements the existing Harlem Township 2020 Comprehensive Plan, providing additional recommendations in land use, communications, and administrative capacity to prepare for development pressures. It is designed to complement the Comprehensive Plan and offers further clarity on open space and density calculations for conservation developments.



WERE ACTIONS TAKEN PER PLAN?




Upon examination of the **Quick Strategy Guide (QSG)**, it is evident that the Strategic Planning Committee (SPC) did not effectively utilize it to innovate and implement solutions.

Reviews of meeting minutes and recordings reveal that the core team lacks adequate organizational skills and resources to develop fact-based near, mid, and long-term plans effectively. Briefs of conversations are verbally provided and appear to be mostly informal and loosely coordinated, and details regarding meeting objectives and attendees with neighboring communities for joint development efforts were not documented and made available for public inspection as of yet if available.

HOW'D WE GET HERE??



While many in our community were unaware, and the majority remain uninformed, we were shocked to learn on February 29, 2024, during an impromptu public announcement at Harlem Church, that Harlem Township's Strategic Planning Committee and Township Trustees have been meeting secretly behind closed doors since July of last year to negotiate the largest annexation of Harlem Township. This merger would integrate our township as one parcel with the second-largest municipality in Ohio. It was disheartening to realize that the township and committee members we trusted to communicate with residents had no better plan than to move forward with what is essentially a sell-out of our rural community under the guise of a merger.

While residents had expressed concerns about possible annexations and rapid growth and development in our area, we had no idea that our trusted leaders were so out of touch and working in collaboration towards such a drastic step. Blind fears about small annexations were used to justify their actions, which we quickly realized were unfounded. They appear to not be listening and are pushing forward towards our township's complete dissolution into a larger government entity, along with new tax assessments starting January 1, 2025.
